Minutes

The City of Nitro Convention and Visitors Bureau March 3, 2020

The Nitro Convention and Visitors Bureau met on Tuesday, March 3, 2020. The meeting was called to order in the training room of the Nitro Police Station. Those in attendance were Mayor Dave Casebolt, Bill Javins, Carmen Kostelansky, Bill Racer, John Young, Julia Washington and Susan Valleau. Also, in attendance was Nitro Councilman John Montgomery and CVB Executive Director Joe Stevens.

A quorum was determined to be present and the minutes were reviewed and a motion to accept the minutes was made by Mayor Casebolt and seconded by Susan Valleau. The motion was adopted.

A financial report was presented by Treasurer John Young for the month of February, A motion was made to accept the report by Susan Valleau and seconded by Julia Washington. The motion was adopted.

Joe Stevens gave his director's report to the board. Stevens requested the board to fund a reception for 90 members of the Society of American Travel Writers at the Mardi Gras Resort on Sunday, May 17 at the cost of \$2500. A motion to approve the expenditure was made by Bill Javins and second by Susan Valleau. The motion was adopted.
