## MINUTES JANUARY 18, 2022

CALL TO ORDER: Mayor Dave Casebolt called the meeting to order at 7:00 pm in Council Chambers and the following were in attendance: Recorder Rita Cox, Ward 2 Councilwoman Cynthia McGill, Ward 3 Councilman Joe Murphy, Ward 4 Councilman Michael Hill, Councilwoman at Large Emily Barr, Councilmen at Large Bill Javins and Andy Shamblin, City Attorney Johnnie Brown, and City Treasurer John Young. Ward 1 Councilwoman Donna Boggs was absent.

FT.-\$7577.50 (2) T&J PROPERTY SOLUTIONS REMOVE AND REPLACE 675 SQ.
