**CALL TO ORDER:** The meeting was called to order in Council Chambers at 7:00 pm. Attending with the mayor were the following: Recorder Rita Cox, Ward 1 Councilwoman Donna Boggs, Ward 2 Councilman Bill Racer, Ward 3 Councilwoman Laurie Elkins, Ward 4 Councilman Michael Hill, Councilmen at Large Bill Javins and John Montgomery, City Attorney Johnnie Brown, and City Treasurer John Young. Councilman at Large Andy Shamblin was not present.

**INVOCATION/PLEDGE OF ALLEGIANCE:** The Invocation was given by Ivan Meadows and the Pledge of Allegiance was led by Councilwoman Donna Boggs.

**FUTURE DATES OF COUNCIL:** Mayor Casebolt said the future dates of Council are January 7 and 27 and February 4.

**APPROVAL OF COUNCIL MINUTES:** RECORDER COX MADE THE MOTION TO APPROVE THE MINUTES OF DECEMBER 3 MEETING WITH COUNCILMAN MONTGOMERY MAKING A SECOND TO THE MOTION AND VOTE WAS FOR THE MOTION.

**OLD BUSINESS**

**SECOND READING REVISION TO ORDINANCE ARTICLE 733 BUSINESS LICENSE:** COUNCILMAN MONTGOMERY MADE THE MOTION THAT COUNCIL PASS ON SECOND READING BY READING OF TITLE ONLY THE ORDINANCE REVISING ARTICLE 733 BUSINESS LICENSE IN REFERENCE TO THE NUMBER OF RESIDENTIAL RENTAL UNITS REQUIRING A \$15 FEE FOR LICENSING. THERE WAS A SECOND BY COUNCILMAN JAVINS AND A UNANMIOUS VOTE FOR THE MOTION.

**REAPPOINTMENT OF STEVE BOGGS TO NITRO REGIONAL WASTEWATER UTILITY BOARD TERM EXPIRING JUNE 30, 2013:** RECORDER COX MADE THE MOTION TO REAPPOINTMENT STEVE BOGGS TO THE NRWU BOARD OF DIRECTORS WITH HIS TERM EXPIRING JUNE 30, 2023. COUNCILMAN MONTGOMERY MADE A SECOND TO THE MOTION WITH ALL COUNCIL MEMBERS VOTING FOR THE MOTION.

**NEW BUSINESS**

**APPOINTMENT OF NRWU BOARD MEMBERS AS MS4 BOARD:** RECORDER RITA COX MADE THE MOTION TO APPOINT THE MEMBERS OF THE NRWU (NITRO REGIONAL WASTEWATER UTILITY) BOARD OF DIRECTORS TO SERVE AS THE MS4 (MUNICIPAL STORMWATER) BOARD OF DIRECTORS. THE SECOND WAS MADE BY COUNCILMAN JOHN MONTGOMERY. Laura Cox said that this is a good fit for the board because of the mutual interests of the two and it fills the requirement of the ordinance to have a board of directors. VOTE WAS UNANIMOUS FOR THE MOTION.

**APPOINTMENT OF TWO COUNCIL MEMBERS TO MS4 BOARD:** COUNCILMAN RACER MADE THE MOTION TO APPOINT COUNCILWOMAN BOGGS AND COUNCILMAN MONTGOMERY TO THE MS4 BOARD WITH A SECOND BY RECORDER COX. THE MOTION CARRIED WITH A UNANIMOUS VOTE.

**ATTORNEY REPORT:** Johnnie Brown did not have a report to present.

TREASURER REPORT: COUNCILWOMAN ELKINS MADE THE MOTION TO ACCEPT THE TREASURER REPORT. THERE WAS A SECOND BY COUNCILMAN HILL. THE MOTION CARRIED.

COUNCILMAN JAVINS MADE THE MOTION TO ACCEPT THE PROPOSAL TO PURCHASE FIRE RESCUE TRUCK-2020 SVI RESCUE 16' BODY FOR \$349,999 FROM SVI TRUCKS REPRESENTATIVE HERITAGE FIRE EQUIPMENT. THERE WAS A SECOND BY COUNCILMAN RACER. COUNCIL VOTED FOR THE MOTION.

MAYOR COMMENTS: Mayor Casebolt said the Nitro Food Pantry has worked hard to put together the food for those who needed.

Nitro City Council,

On behalf of the Nitro Land Reuse Authority of Kanawha and Putnam Counties, I would like to formally make a recommendation to begin the process of transferring the tax lien property acquired by the City of Nitro during the 2017 and 2018 Kanawha County tax sales. The adjacent property owners have an obligatory 120-day period to purchase the quick claim deeds on the 2017 properties. That period began on December 20, 2019. Since each adjacent property owner has been made aware with proper notice of their rights, several interested individuals have since made contact. The city can begin to finalize these transactions after April 20, 2020. The 2018 tax liens follow a similar process, in that the adjacent property owners have the same 120-day purchase period, beginning on December 27, 2019. However, one notable difference is that the city only possesses the tax liens on these properties. Once the 120-day period has passed, unsold tax liens can be assigned to the LRA at \$10 per property in the Kanawha County Clerk's Office. I estimate that up to 20 deeds/tax liens, that will not be sold or assigned to adjacent property owners, will begin the process of transferring to the LRA no later than June 1, 2020. Once the properties have sold, the LRA will reimburse the city at their cost, plus 10% interest. If a property is set to be sold for less than the initial investment, City Council will be presented with a recommendation and plan for said property to offset the loss.

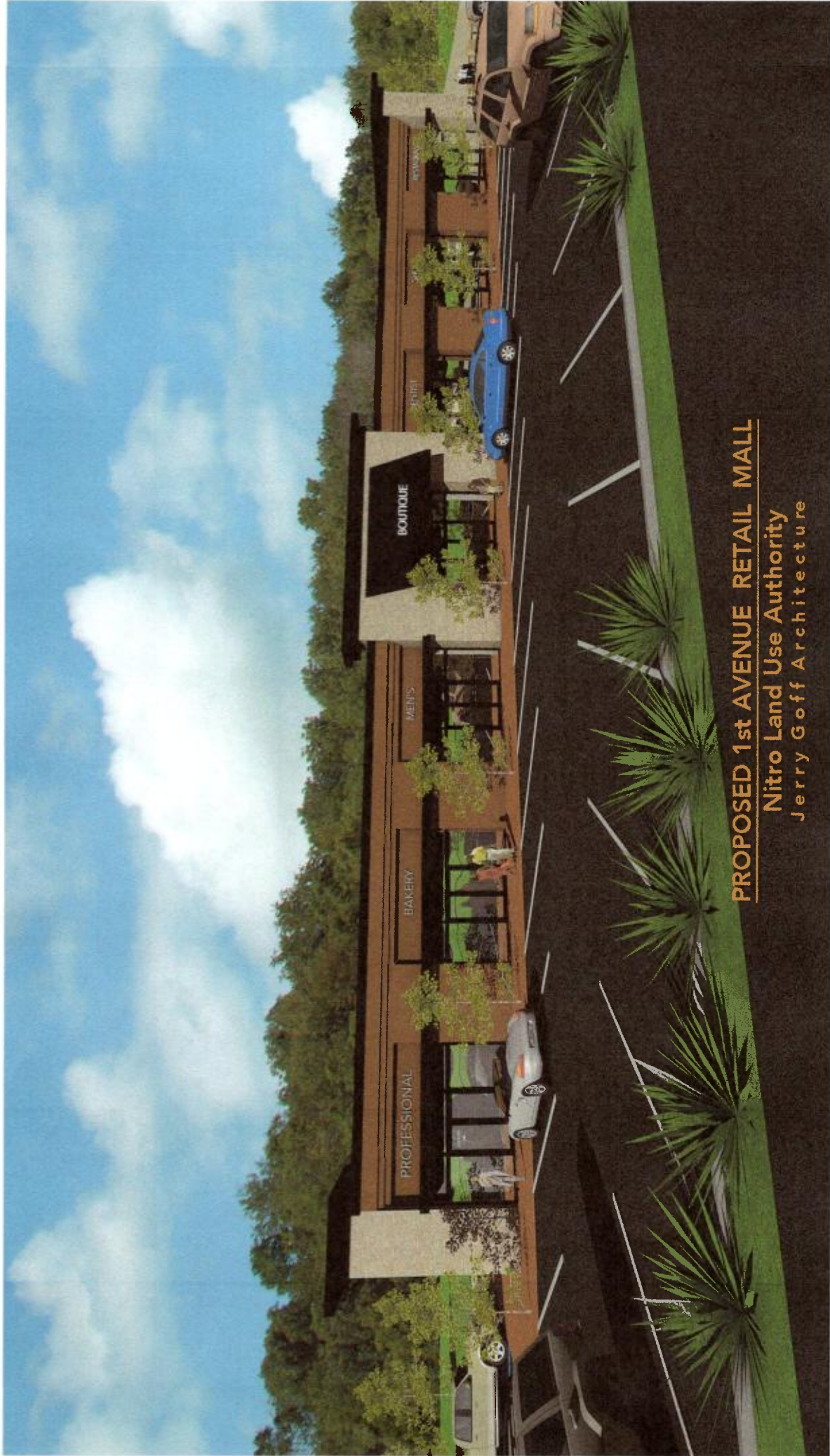
The LRA will also function as the consultants for the development of the Antiques on the Avenue property. The board will contract with professional services and make recommendations to council on the best use and occupancy of the development. All invoices and costs incurred for the project will be fulfilled by the city.

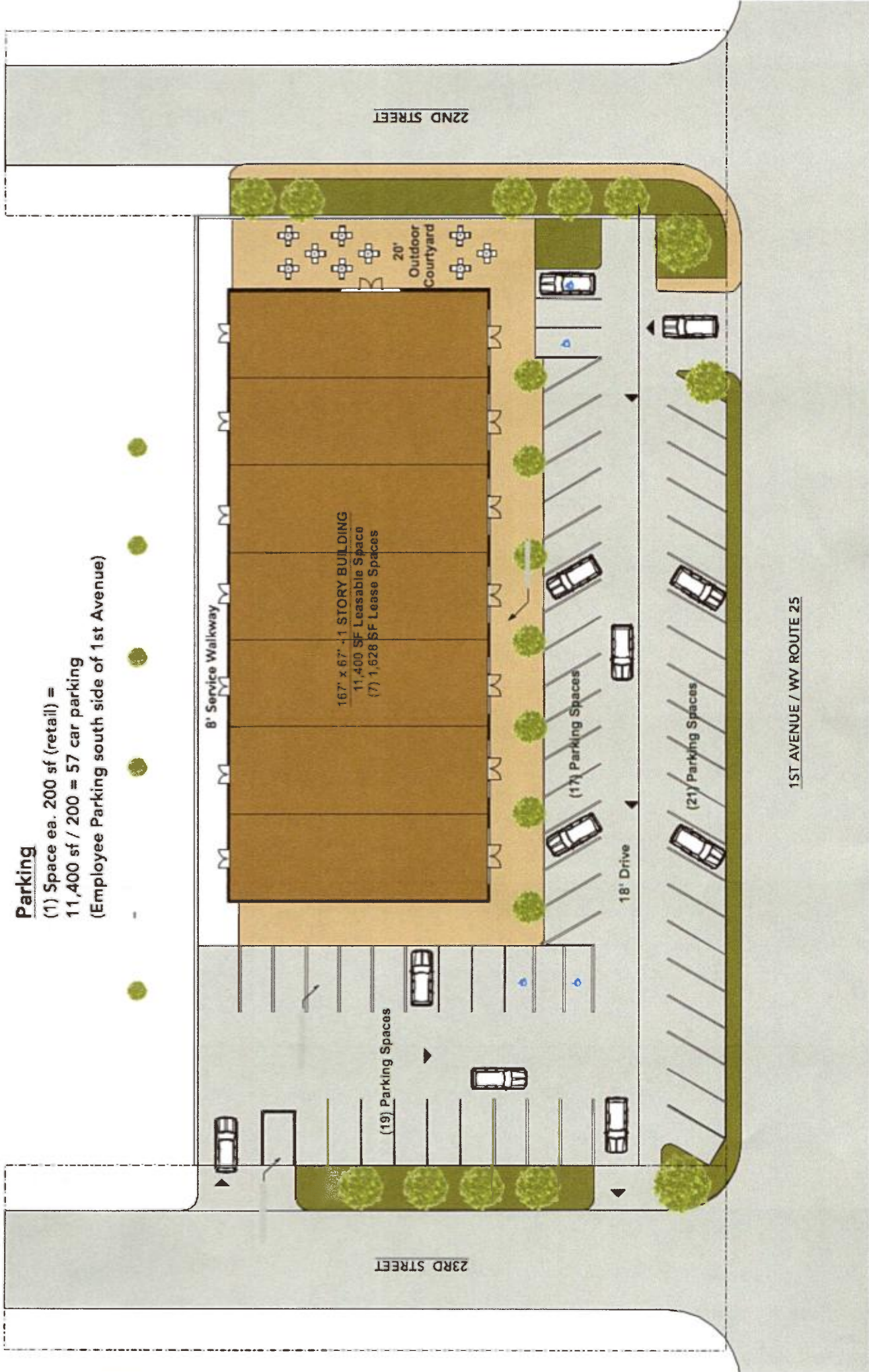
**PROPOSED 1st AVENUE RETAIL MALL**
